Re: Response to Public Records Request

Dear Media Sources:

I am in receipt of your public records request, wherein you seek a copy of the complaint the Celina Police Department received regarding Assistant Principal Renee Kramer.

Enclosed please find the record responsive to your request. Please note that redactions have been made pursuant to the Family Educational Rights and Privacy Act ("FERPA"). Under FERPA, an educational agency is prohibited from releasing "education records" and "personally identifiable information" of a student without the written consent of the student's parent/guardian or an eligible student. "Education records" are defined as any records, files, documents, and other materials which "contain information directly related to a student" and "are maintained by an educational agency or institution..." 20 U.S.C. §1232g(a)(4)(A). The Public Records Act does not apply to records where the release of which is prohibited by state or federal law. R.C. 149.43(A)(1)(v). As a result, the Board is required by FERPA to redact personally identifiable student information. See *State ex rel. ESPN, Inc. v. Ohio State University*, 132 Ohio St.3d 212, 2012-Ohio-2690.

Additionally, please note that the Public Records Act only obligates the District to produce "public records" in response to records requests. *State ex rel. White v. Goldsberry*, 85 Ohio St.3d 153, 154, 1999-Ohio-447. There is no duty to provide items which do not serve to document the organization, functions, policies, decisions, procedures, operations, or other activities of the District, because such documents do not meet the definition of a "public record" under R.C. 149.03(A)(1) and 149.011(G). In that regard, please be advised that all non-public records and/or data have been redacted, including home addresses, personal telephone number(s), personal e-mail addresses, dates of birth, and social security numbers. See R.C. 149.43(A)(1)(a); R.C. 149.43(A)(3); R.C. 3319.39; *State ex rel. Beacon Journal Publishing Co. v. Akron*, 70 Ohio St. 3d 605 (1994); *State ex rel. Dispatch Printing Co. v. Johnson*, 106 Ohio St. 3d 160 (2005).


